AMATEUR ATHLETIC WAIVER AND RELEASE OF LIABILITY—READ BEFORE SIGNING

- 1) The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and or death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

- 3) I willingly agree to comply with the stated and customary terms and conditions for participation. Code of Conduct

We expect all persons who choose to participate in a Sumiton Christian Youth Athletics (SCYA) event to exemplify a Christ like behavior and to comply with Biblical Standards {I Peter 2:13-15}. Failure to adhere to any of the following policies will be grounds for disciplinary action, suspension and/or dismissal:

1. All persons must honor and respect God the Father, Jesus Christ, the Holy Spirit, and God's Holy Word. {Matthew 22:37-38}.
2. All players must follow all guidelines and regulations established within each team. Disruptive behavior is not permissible.
3. Rebellion, disobedience, and disrespect [i.e. talking back or arguing with a coach or game official directly or indirectly] will not be tolerated. {I Samuel 15:23, Hebrews 13:17}
4. All persons must respect church and school property and equipment. The defacing or destruction of any property, walls, equipment, or furnishings will result in disciplinary action, as well as reimbursement for any damage caused. {Matthew 25:14-30; Luke 43-48}.
5. No player is permitted to leave practice without permission. All players must be under coaches or parent's supervision at all times.
6. Stealing, cheating, use of obscene language, possession of obscene literature, and conduct that violates Christian principles in any way, will not be tolerated and may be grounds for suspension and/or dismissal. {Exodus 20: 1-17; James 3: 10-11; Matthew 6; 22-23}.
7. Smoking or possession of cigarettes, prescription or non-prescription drugs, or alcoholic beverages of any kind is positively prohibited on church or school grounds. Any player failing to comply with this standard will be automatically dismissed. For the sake of personal and school testimony, total abstinence and absence {use or possession} from tobacco, alcoholic beverages, and illegal drugs is expected of all players at all times, twenty-four [24] per day, seven [7] days a week. Any player failing to comply with this standard will be automatically dismissed. {I Corinthians 6:19-20}. Absolutely no medication is allowed in a player's possession. Medication must be checked in with game officials and will be administered by that person.
8. Players may not bring weapons of any kind [including pocket knives] to a practice or games.
9. Above all, in order to maintain a loving atmosphere and environment, all players are expected to exemplify a Christ-like character in cultivating good social relationships. Behavior such as name calling, ridiculing others, tale bearing, lying, etc. will not be tolerated.

Discipline is necessary for the player as well as the whole team. It is impossible for learning to take place on a team unless good order is maintained. Therefore, each coach is given the liberty of making and enforcing team regulations in the manner he or she feels in accordance with Christian principles and discipline as set forth in the scriptures of The Holy Bible. SCYA expects full cooperation from both players and parents. All player or parent complaints will be expected to be taken through the proper chain of authority in a respectful manner.

ALL PARENTS MUST READ AND SIGN

All youth athletic governing bodies have imposed the following conduct fines and penalties. SCYA **will not**, and **can not**, pay out these fines, so you as the parent or guardian of the player or cheerleader must read and sign this in order for your child to participate. These fines will be your responsibility.

Conduct: Conduct of any spectator, coach, officer, and or/player/cheerleader, which leads to ejection shall be reported to the governing body. Coaches and spectators will be subject to fines below, along with any other action deemed necessary by the governing body.
